Equity Golf Membership entitles the Member and his/her spouse or Significant Other and children under the age of 25 to use all of the Club amenities. Golf Members are not charged green fees or court fees for use of the golf and court sport facilities but are required to pay golf cart fees. Golf Members may request a tee time eight days in advance and are entitled to a seven-day sign up privilege to reserve court sport times.

GOLF WAITLIST

The Golf Waitlist entitles the Member and his/her spouse or Significant Other and children under the age of 25 to use all of the Club amenities. A Golf Waitlist Member is eligible to play in all non-trophied Men's and Ladies Day events (deadline is Noon on Monday before the desired Men's Day and Noon on Tuesday of the desired Ladies Day), Sunday Socials (paying cart and event fees, on a space available basis) and participate in clinics including the Mulligan's Ladies Group. Golf Waitlist Members are charged related green fees and cart fees and can reserve a tee time 24 hours in advance of desired time November through April and four days in advance May through October, paying a cart fee only. They have unlimited access to the practice facilities and all non-golf amenities year-round. Golf Waitlist Members are not charged court fees.

MEMBER IN WAITING

A Member in Waiting Position includes no amenities and no dues. It simply reserves a position to eventually become a Golf Waitlist Member and secures the fees that are in effect on the date the Member in Waiting agreement is signed and the fee is paid. A Member in Waiting position can also be held in addition to a Sport or Social Membership.

Nonrefundable Member in Waiting Initiation Fee \$10,000*

SPORT MEMBERSHIP

Equity Sport Membership entitles the Member and his/her spouse or Significant Other and children under the age of 25 to use all of the Club amenities. Sport Members are not charged green fees or court fees. Sport Members are entitled to a seven-day sign up privilege to reserve court sport times. In addition, Sport Members shall be entitled to use the golf facilities up to six times during the winter season, from November through April each year, as well as four additional times on specified Men's and Ladies Days, and unlimited golf play during the summer season. Sport Members are entitled to a four-day sign up privilege to reserve golf times and pay cart fees only.

SOCIAL MEMBERSHIP

A Social Membership entitles the Member and his/her spouse or Significant Other and children under the age of 25 use of the pool, fitness, and social facilities of the Club. In addition, Social Members shall be entitled to unlimited use of the court sport facilities. Social Members are not charged court fees and will be entitled to a seven-day sign up privilege to reserve court sport times. Social Members may play six golf rounds per household, per fiscal year, as the guest of a Golf Member, paying the unrelated guest fee and cart fee.

DETAILS

- Non-Refundable Equity Members are not entitled to a refund of the membership contribution upon resignation. A Non-Resident member with a non-refundable equity membership may resign their membership at any time by paying the equivalent of twelve months dues from the date of resignation and turning their membership into the club at the end of the twelve month period. The resigned member will have no further obligation to the club. A Resident non-refundable equity Golf or Sports member may resign their membership by paying the equivalent of twelve months dues from the date of their resignation and converting to a non-refundable Social membership at the end of the twelve month period.
- Per the By-laws of the Club, Residents of Kensington who join Kensington Golf & Country Club must agree to maintain the Social level membership as long as they own a residence in the community.
- The Capital Reserve Fund monthly fee has been approved by the Membership to help fund capital projects.
- The Master Plan Fee has been approved by the Membership to specifically fund the Clubhouse, Pool, Golf Shop, Maintenance Building and Pickleball Court improvements.
- All Members have a yearly Food and Beverage minimum of \$600 Family | \$300 Single.
