

Non-Refundable Equity Members are not entitled to a refund of the membership contribution upon resignation. A Non-Resident Member with a non-refundable equity membership may resign their membership at any time by paying the equivalent of twelve months dues from the date of resignation and turning their membership into the club at the end of the twelve month period. The resigned member will have no further obligation to the club. A Resident non-refundable equity Golf or Sports Member may resign their membership by paying the equivalent of twelve months dues from the date of their resignation and converting to a non-refundable Social membership at the end of the twelve month period.



Per the By-laws of the Club, Residents of Kensington who join Kensington Golf & Country Club must agree to maintain the Social level membership as long as they own a residence in the community.
